In case of default in the payment of any invoiced amount for equipment and/or merchandise, I/We jointly and severally promise to pay: 1) interest at the rate of one and one-half per centum (1 1/2%) per month on any past due balance and 2) the actual expenditures, including all attorney's fees and any court costs incurred in the collection of the invoiced amount.

B. Upon any default hereunder, or upon any bankruptcy proceeding or other legal action taken by or against the undersigned, or any of them, or upon the death or legal incapacity of the undersigned, or any of them, or in the event Vermeer North Atlantic Sales & Service at any time deems itself unsafe or insecure, all open invoices, less applicable discounts, shall become due and payable forthwith, without notice or demand to the undersigned, or any of them, and the amount thereby becoming due and with respect to which no payments have been made, shall 1) bear interest at the rate of one and one half (1 1/2%) per month until full settlement is realized and 2) include items 2 as set forth under "A" above.

C. Any continued past due balances will result in cancellation of credit line.

D. The undersigned, I or WE jointly and severally acknowledge that he/she has executed this agreement in consideration of equipment and/or merchandise forwarded to him.

E. Payments by applicant are to be made from the Vermeer North Atlantic Sales & Service invoice. Monthly statements will not be sent.

F. Applicant hereby authorizes the release of credit information to Vermeer North Atlantic Sales & Service from any source including credit bureau reporting agencies and applicant's bank. The following authorization shall apply to this application and subsequently for the purpose of update, renewal, or extension of such credit and for reviewing or collecting the resulting account.
